Notice

It is for the information of all the unit holders/ managements of establishments covered under erstwhile J&K EPF Act 1961 that the JKEPFO is under transition with Central EPFO and majority of subscribers' accounts have been compiled and transferred to the Central Portal. However, various establishments have not complied the Circular instructions of this office **issued vide No. Addl.PFC/K/2622-2628 dated 05-11-2020** and published in daily Greater Kashmir dated 06-11-2020 resulting in non compilation and pendency of subscribers' accounts. Now as a final opportunity it is once again impressed upon all such managements/ unit holders by medium of this notice to deposit the contributions if any pending up to October, 2019 and update the status accordingly on our official portal within a weeks time positively.
