Whereas, on the recommendation of J&K Services Selection Board vide its Letter No. SSB/Secy/Sel/2018/7751-57, Dated 06-07-2018 received through Administrative Department's Letter No. L&E/EPO/17/2011-I, Dated 31.08.2018 recommended appointment of 01 selected candidate namely **Sh. Javaid Ahmed, S/o Mohd Aslam, R/o Gohlad Mendhar Poonch** against the post of Junior Assistant in the Provident Fund Organization (Divisional cadre Jammu) under ALC category;

Whereas, proceeding on the recommendations of J&K Service Selection Board, appointment Order was issued by this office in favour of the above selected candidate under No. **75-PFC of 2018, Dated 25-09-2018**. The order of appointment was sent to the appointee on his residential address on 27-09-2018 through registered post and same was also published in Daily Newspapers "**State Observer, Jammu**" and "**Srinagar Times**" on 28-09-2018.

Whereas, by virtue of the above said order, the appointee was required to report to the office of Additional Provident Fund Commissioner, Jammu within 21 days from the date of issuance of the order and failure of the appointee to join within the stipulated period of time shall lead to the cancellation of his appointment abinitio without any further notice;

Whereas, the appointee, **Sh. Javaid Ahmed, S/o Mohd Aslam, R/o Gohlad Mendhar Poonch** has failed to join in the Office of Additional Provident Fund Commissioner, Jammu within the stipulated time of 21 days, as reported by Additional Provident Fund Commissioner, Jammu vide his communication No Addl.PFC/J/2432 dated 17-10-2018;

In view of the above facts, the appointment of **Sh. Javaid Ahmed, S/o Mohd Aslam, R/o Gohlad Mendhar Poonch** as Junior Assistant in the J&K Employees Provident Fund Organisation shall be deemed to have been cancelled abinitio.
